This Agreement will be governed by and construed in accordance with the laws of Switzerland. Both parties agree to move immediately to Mediation via the International Mediation & Arbitration court in the event of a dispute. Before the International Mediation and Arbitration Court of the World Association of Médiarbitrage and, in accordance with its procedure of Mediation, in a first phase of Mediation, the parties will have to try to resolve amicably any conflicts arising from the contract or in relationship with it and the reports or legal effects directly or indirectly related to it or relating to a wrongful act between the parties.

In a second phase, following the previous phase and regardless of the outcome of the first phase of mediation, the arbitration will settle the dispute definitively.

The International Court of Mediation and Arbitration applies its International Rules of Arbitration to which the parties refer, to the exclusion of all other courts. The Deliberate Council will be held in Geneva or Paris.

According to the International Rules of Mediation, the Board of Deliberation will be composed of at least three (3) Judge-Mediators.

Agrees, at the request of the parties, that the International Court of Mediation and Arbitration shall rule with the powers of amiable composer.

The arbitral award of the International Court of Mediation and Arbitration is final.

12. No waiver:

Any failure by either party to enforce the other party's strict performance of any provision of this Agreement shall not constitute as a waiver of its right to subsequently enforce such provision or any other provision of this Agreement.

The Parties have executed this Agreement as of the date shown above. The Parties have read and agreed to the terms of this Agreement.
